## Eligibility Requirements

---

The USRowing World Rowing Championships selection process is open to all athletes who meet all the following criteria. Athletes must comply with these criteria through the date of the completion of the World Rowing Championships:

- Athlete must be Championship Member of USRowing and be in good financial and other standing with USRowing.
- Athlete must have current Safe Sport training.
- Athlete over the age of 18 must complete and pass a background check or have a valid background check on file upon invitation to selection camp or nomination to the team.
- Athlete must complete and submit a 12 Lead ECG that is signed by a doctor or have a valid submission on file upon invitation to selection camp or nomination to the team.
- Athlete must meet eligibility rules to compete for the United States under IOC, USOPC and World Rowing governance.
- Athlete must hold United States citizenship at the time of selection. Athlete must hold a valid passport that meets the travel requirements of the nation hosting the World Rowing Championships.
- Athlete must abide by the 2026 Senior National Team Selection Procedures and the USRowing Code of Conduct, Bylaws, Rules of Rowing, and other USRowing rules, requirements, and regulations.
- Athlete must have read and sign a copy of the 2026 [USRowing National Team Agreement \(Appendix G\)](#).

## Anti-Doping

---

All athletes participating in selection for the United States National Team must be in compliance with WADA (World Anti-Doping Agency), United States Anti-Doping Agency (USADA), IOC, USOPC, World Rowing and USRowing rules, decisions, policies, and procedures relating to banned substances, including but not limited to obtaining and maintaining current therapeutic use exemptions as needed. USRowing may implement additional eligibility requirements related to banned substances as necessary in order to maintain compliance with WADA, USADA, IOC, USOPC, World Rowing and USRowing rules, policies, and procedures; any such additional requirements will be incorporated herein and published as soon as practicable.

Athletes who violate WADA, USADA, IOC, USOPC, World Rowing, or USRowing rules, decisions, policies, or procedures relating to banned substances will be subject to penalties as established by the respective organization. Athletes are responsible for checking any medication they are taking and making sure the medication is not on the banned list. ## USRowing Competitive Standard Times (CST)

The purpose of the selection procedures is to select qualified athletes and crews to represent the United States at the World Rowing Championships. In order to ensure that all selected crews meet the level to be representatives of our country, minimum time standards are part of the selection procedures.

Rowing has no official world records. For the Elite level World Rowing registers World Best Times during all World Rowing events (World Cups, Continental and World Championships, Olympics). These times are not called 'records' because of the variations rowers experience in wind, water temperatures and flow. For Under 23 and Under 19 World Rowing only registers World Rowing Championships Best Times.

World Best Times are helpful for developing standards. In order to determine fair and comparable standards across the events there are more criteria to take into consideration. The USRowing Competitive Standard Times (CST) for the Elite events are developed based upon three elements:

- Registered World Best Times;
- Theoretical calculation of the relative speed for each event based on the assumed power and weight of the World Class athletes and the drag of the boat;

- Statistical analysis of historical data of Olympics, World Rowing Championships and World Cups since 2001: average winning times, relative time per event in relation to M8+ for men and W8+ for women, relative time per lightweight event in relation to the open equivalent, spread in finals, trend per event over the last Olympic cycle.

For the U23 and U19 events the World Rowing U23/U19 Championships Best Times are not used for determining the standard times. In some cases, the best times are set by exceptional athletes who are also competing at elite level. Furthermore, the age categories are part of the pathway, so the standard should reflect this. USRowing uses internationally accepted percentages relative to the elite level that are supported by research and statistical analysis: 97% for U23 events and 95% for U19 events.

### **Olympic Events Selection Camps**

M2x, W2x, M4x, W4x, M4-, W4-, M8+, W8+

### **National Selection Regatta**

M1x, W1x, M2-, W2-

### **World Rowing Championships Trials**

LM1x, LW1x, LM2x, LW2x

## **2026 NATIONAL TEAM ANNOUNCEMENT**

USRowing will announce the 2026 Senior National Team no later than seven days after the final selection event.



## Olympic Events Selection Camps

---

### SELECTION PROCESS OLYMPIC EVENTS SELECTION CAMPS

*M2x, W2x, M4x, W4x, M4-, W4-, M8+, W8+*

#### SELECTION CAMP I

The following apply to both men's and women's selection.

- A. There will be approximately sixteen athletes invited to the selection camp. The purpose is to bring the fastest individual athletes together allowing to assemble the best combination of talent. The selected athletes will participate in different boat classes in World Cup II, TBD and World Cup III, Lucerne.
- B. No more than twelve athletes (eight sweep and four scull) will be selected for World Cup II and World Cup III. The objective of the camp is to select the best athletes, not to select boats.
- C. Athletes who want to be considered for the selection camp must submit at least one 6,000m erg test and at least one 2,000m erg test on the [USRowing website](https://www.usrowing.org) before January 1, 2026, and must participate in the Fall Speed Orders (November 14-16 2025, West Windsor, NJ). If an athlete is unable to fulfill one of these requirements because of injury or illness, the athlete needs to receive medical clearance from the appropriate member of the USRowing Medical Committee. Athletes who participated in the 2025 World Rowing Championships are exempt from participation in the Fall Speed Orders.
- D. The winning boats of the Fall Speed Orders in 1x and 2- earn automatic invitations. The remainder of the athletes will be invited upon discretion of the Chief High Performance Officer. The following criteria will be used when deciding discretionary invitations (listed in no particular order):
  - a. Performance in 2025 and 2026 National Team Testing, Speed Orders and Trials;
  - b. Performance in 2025 international competition;
  - c. Coach's recommendation.
- E. Before the start of the selection camp a document shall be published to explain the objectives of the camp, the program, the selection criteria and the selection protocols that will be used. In order to participate in the camp, the athletes have to acknowledge the document.

- F.** The Chief High Performance Officer shall, in consultation with the High Performance Committee, appoint a Lead Coach and a Selection Panel for the selection camp. The selection panel consists of the Chief High Performance Officer or their designee, a member of the High Performance Committee or their designee, and a member of the Athlete Council or their designee. Final selection decisions shall be the responsibility of the Selection Panel.
- G.** The objective of the camp is to select the best athletes based on the following factors (listed in no particular order):

  - a. Athlete's technical skills in different boat classes and seats;
  - b. Athlete's absolute power and power efficiency;
  - c. Athlete's team dynamic skills;
  - d. Overall performance at selection camp;
  - e. Meets minimal eligibility criteria set forth on page 3.
- H.** At the conclusion of the selection camp the Lead Coach shall present the proposal to the Selection Panel. After approval by the Selection Panel the decisions shall be published.

## SELECTION CAMP II

The following apply to both men's and women's selections.

- A. There will be approximately twenty-four athletes (including coxswains) invited to the selection camp.
- B. The objective of the camp is to select the boats and crews. Boats will be prioritized based upon competitive level in relation to the international competition.
- C. The athletes that were selected in Selection Camp I earn automatic invitations to Selection Camp II.
- D. Additional athletes who want to be considered for the selection camp must submit at least one 6,000m erg test and at least one 2,000m erg test on the [USRowing website](https://www.usrowing.org) before July 1, 2026, and must participate in the Summer Speed Orders (July 3-5 2026, West Windsor, NJ). If an athlete is unable to fulfill one of these requirements because of injury or illness, the athlete needs to receive medical clearance from the appropriate member of the USRowing Medical Committee.
- E. The Top-2 boats of the Summer Speed Orders in 1x and 2- earn automatic invitations. The remainder of the athletes will be invited upon discretion of the Chief High Performance Officer. The following criteria will be used when deciding discretionary invitations (listed in no particular order):
  - a. Performance in 2025 and 2026 National Team Testing, Speed Orders and Trials;
  - b. Performance in 2025 and 2026 international competition;
  - c. Coach's recommendation.
- F. Coxswains will be invited based upon recommendation of the Coxswains Panel. The Coxswains Panel consists of retired Senior National Team coxswains, representatives of Athlete Counsel and High Performance Committee, and the Lead Coaches for the camp. Apply through the link listed in [Appendix L, Coxswain Selection Procedures](#), by April 15, 2026. The review period will end and applicants will notified about decisions of the Coxswain Panel by June 6, 2026. - G. Before the start of the selection camp a document shall be published to explain the objectives of the camp, the program, the selection criteria and the selection protocols that will be used. In order to participate in the camp, the athletes have to acknowledge the document.

- H. The Chief High Performance Officer shall, in consultation with the High Performance Committee, appoint a Lead Coach and a Selection Panel for the selection camp. The selection panel consists of the Chief High Performance Officer or their designee, a member of the High Performance Committee or their designee, and a member of the Athlete Council or their designee. Final selection decisions shall be the responsibility of the Selection Panel.
- I. The objective of the camp is to select the crews for the team boats based on the following factors (listed in no specific order):
- Athlete's specific technical skills for boat class and their seat;
  - Athlete's absolute power and power efficiency;
  - Athlete's team dynamic skills;
  - Overall performance at selection camp;
  - Meets minimal eligibility criteria set forth on page 3.
- J. All selected crews must be able to meet at least the standard of 95% of CST, to be officially named to the 2026 National Team. Crews that fail to prove that they can meet this standard will not be named to the team. The standards relate to the USRowing Competitive Standard Times (CST) for each event. The standard is 95% of CST under neutral or favorable wind conditions and a water temperature of 70° Fahrenheit or higher.

- K. At the conclusion of the selection camp the Lead Coach shall present the proposal to the Selection Panel. After approval by the Selection Panel the decisions shall be published.
- L. The selected athletes must sign and submit their declaration of intent to compete in the 2026 World Rowing Championships to the USRowing Chief High Performance Officer, or their designee, no later than three days after publication of the panel decision.

- M.** Each selected athlete will be named to the 2026 Senior National Team, provided the athlete submit their declaration of intent to compete on time and satisfy the minimum eligibility criteria set forth on page 3.

## **SELECTION PROCESS AT SELECTION CAMPS**

Selection camps are used to determine the top athletes and the fastest combination of top athletes, allowing the fastest individual athletes to come together in one location to assemble the best combination of talent in the team boats. In order to do so, at selection camps, individual athletes will be selected to form the best combination of talent for each boat. The selection camp process ensures that athletes in attendance have an opportunity to be selected for the team boat. However, the selection camp process, while based on objective performance markers, also must include team-related performance assessment. The dynamic of teamwork, leadership, and movement in a team boat requires development and assessment over time.

Results of measurable competitive processes at the selection camps, including, but not limited to time trials and seat racing, will be made available for athletes participating in the respective selection camp to review within 24 hours of the end of practice. USRowing will keep records of the underlying data used to evaluate athletes in the selection camp process for a period of six months after the 2026 World Rowing Championships.

## **GRIEVANCES RELATED TO THE SELECTION PROCESS**

An athlete or coach who has grievances related to the selection process, is entitled to petition for a hearing by the Selection Panel. The hearing will include an appropriate representative of the High Performance Committee and the petitioner unless the petitioner waives this right, in which case the hearing will be conducted with written briefs only. A decision will be issued within two hours of the hearing. The petitioner may be entitled to further resolution of their grievance through the Bylaws of USRowing or USOPC.

## National Selection Regatta

---

### SELECTION PROCESS NATIONAL SELECTION REGATTA

*M1x, W1x, M2-, W2-*

- A. The 2026 National Selection Regatta will follow the 6-lane progression as outlined in [Appendix C](#) of the 2022 Selection Procedures. The event will follow the rules as outlined under [Appendix A: General Trials Rules](#).
- B. The winning boat in each event at the 2026 National Selection Regatta may attend World Cup II, TBD and/or World Cup III, Lucerne, to earn the right to represent the United States at the 2026 Senior World Championships.
- C. The athletes in that boat must satisfy the minimum eligibility criteria set forth on page 3 and declare their intent to compete in World Cup II and/or World Cup III in writing to the USRowing Chief High Performance Officer, or their designee. The Petition Deadline is 5pm EST May 4<sup>th</sup>, 2026.
- D. Should the winning boat's athletes decline, fail to declare their intent, or fail to meet the minimum eligibility criteria, the second-place finisher, if within a margin of 1% of the winning boat, will be given the option to take the spot. The athletes in 2<sup>nd</sup> place boat must satisfy the minimum eligibility criteria set forth on page 3 and declare their intent to compete in World Cup II and/or World Cup III in writing to the USRowing Chief High Performance Officer, or their designee. If the second-place crew is deciding whether to petition they have a minimum of 24 hours to file their petition or by 5pm EST May 8<sup>th</sup>, 2026, whichever is longer. If second place also declines or fails to meet the minimum eligibility criteria, the Chief High Performance Officer reserves the right to nominate a crew for that boat class in Selection Camp II.
- E. Each winning boat is required to nominate a coach who is required to travel with the crew for the length of World Cup II and/or World Cup III. Exceptions to this rule may only be granted by the Chief High Performance Officer. Nominated Coaches must meet the requirements in [Appendix D – Coaches](#).
- F. In order to be named to the 2026 National Team in these events, the boat must place in the top eight (or top 50% if less than 16 boats are entered in the event) at World Cup II or World Cup III.
- G. Each boat qualifying through a top eight finish (or top 50%, as applicable), as described above, must declare their intent to compete in the 2026 Senior World Championships, in writing, to the USRowing Chief High Performance Officer, or their designee, by 5pm EDT on Thursday, July 2<sup>nd</sup>, 2026. Failure to declare intent by this deadline shall result in forfeiture of the nomination based on their respective World Cup result. The boat will

be named to the 2026 Team upon timely submission of their declaration of intent to compete, provided they meet the minimum athlete eligibility criteria set forth on page 3.

- H. Each boat that qualifies through World Cup II or World Cup III is required to nominate a coach with their declaration of intent to compete, who is required to travel with the crew for the length of the 2026 Senior World Championships. Exceptions to this rule may only be granted by the Chief High Performance Officer. Nominated Coaches must meet the requirements in [Appendix D – Coaches](#).
- I. Should the qualified boat fail to declare their intent to compete at the 2026 Senior World Championships, or if the boat does not qualify through the requisite placing at World Cup II or World Cup III, the Chief High Performance Officer reserves the right to nominate a crew for that boat class in Selection Camp II.
- J. USRowing will publish all submitted declarations to compete at the 2026 Senior World Championships and an updated list of Selection Camp II events by 5pm EST on Friday, July 3<sup>rd</sup>, 2026.



## World Rowing Championships Trials

---

### SELECTION PROCESS WORLD ROWING CHAMPIONSHIPS TRIALS

*LM1x, LW1x, LM2x, LW2x*

- A. The Chief High Performance Officer shall, in consultation with the High Performance Committee, appoint a Selection Panel for the World Rowing Championships Trials. The selection panel consists of the Chief High Performance Officer or their designee, a member of the High Performance Committee or their designee, and a member of the Athlete Council or their designee. Final selection decisions shall be the responsibility of the Selection Panel.
- B. The 2026 World Rowing Championships Trials will follow the 6-lane progression as outlined in [Appendix C](#) of the 2026 Selection Procedures. The event will follow the rules as outlined under [Appendix A: General Trials Rules](#).
- C. For the 2026 World Rowing Championships Trials time standards will be applied for the finals. These standards relate to the USRowing Competitive Standard Times (CST) for each event. The standard is 95% of CST under neutral or favorable wind conditions and a water temperature of 70° Fahrenheit or higher.

- D. The Selection Panel will evaluate meteorological and water conditions and may adapt the required Trials Standards. The Trials Standards will be communicated no later than one hour before the first final race at the World Rowing Championships Trials. The Trials Panel has the right to lower the standard for individual events if actual meteorological and water conditions change during the events.
- E. Only boats that meet the Trials Standards can declare their intent to represent the United States at the 2026 World Rowing Championships in their event.
- F. The winning boat in each event at the 2026 World Rowing Championships Trials that meets the required Trials Standard can declare their intent to represent the United States at the 2026 World Rowing Championships in their event.
- G. The athlete(s) in that boat must satisfy the minimum eligibility criteria set forth on page 3 and declare their intent to compete in the 2026 World Rowing Championships in writing to the USRowing Chief High Performance Officer, or their designee, no later than four hours after the final race at the World Rowing Championships Trials has been

declared official.

- H. Should the winning boat's athlete(s) decline, fail to declare their intent or fail to meet the minimum eligibility criteria set forth on page 3, the second-place finisher, if second place meets the required Trials Standard, will be given the option to declare their intent. If second place doesn't meet the standard, also declines or fails to meet the minimum eligibility criteria, the Chief High Performance Officer reserves the right to decline to send a boat to the World Rowing Championships for the event in question.
- I. Each qualified crew must nominate a coach who is required to travel with the crew for the length of the 2026 World Rowing Championships. Exceptions must be approved by the Chief High Performance Officer. Nominated coaches must meet the requirements in [Appendix D – Coaches](#).
- J. The selected athletes in the events LM1x, LW1x, LM2x, LM2x and their respective coaches are required to pay, at the trial's site, the 2026 World Rowing Championships Fees covering local travel, support, and room and board expenses. The Fees exclude athlete(s) and coach airfare, boat and oar rental, and boat transportation costs; these costs and associated logistics are the responsibility of the athlete(s) and coach. The 2026 World Rowing Championships Fees will be announced and posted by May 1, 2026.
- K. For issues and conflicts occurring during trial events the [USRowing National Selection Event Due Process Checklist](#) will be followed.

## **Funding Olympic Boat Classes for 2026**

---

For all athletes selected in Selection Camp I and the National Selection Regatta the participation at World Cup II TBD and World Cup III Lucerne will be funded.

All Olympic boat classes that qualify at NSR I or NSR II and meet the World Cup criteria will be funded.

All Olympic boat classes that are selected in Selection Camp II will be ranked according to their performance relative to the Competitive Standard Times during the selection camp. In the case of funding limitations, boats will be funded in order of the ranking.

Unfunded participation in an Olympic boat class can be eligible for reimbursement if the boat places top-6 at the 2026 World Rowing Championships.

All athletes and coaches attending the 2026 World Rowing Championships in an unfunded Olympic boat class will be responsible for all costs. The fee will be posted by May 1, 2026. The fee will not include the cost of boat rental, oars, or airfare. The fee must be paid on or before August 9, 2026.

## Coaches and Staff

---

### COACHES

Trials boats must propose one coach for their boat to the 2026 World Rowing Championships subject to meeting the criteria outlined in [Appendix D – Coaches](#). For selection camp boats the Lead Coach proposes the coach for each crew in consultation with the selected athletes.

The Chief High Performance Officer will select the coaches for each crew based on the following criteria no later than three days after the day of declaration. All proposed coach candidates will be evaluated according to the following criteria (listed in no specific order):

- a) Choice of and compatibility with the selected crew;
- b) Demonstrated commitment to the high-performance program;
- c) International and domestic coaching experience.

Once the Team is selected all coaches must abide by [Appendix D – Coaches](#).

### STAFF

The Chief High Performance Officer will select the team manager, doctor, trainers, and other related staff.

### REPLACEMENT OF AN ATHLETE OF THE SENIOR NATIONAL TEAM

In the event of a vacancy in a boat of the 2026 Senior National Team, that vacancy will be filled according to [Appendix I – Removal and Replacement of an Athlete, Coach or Staff Member from the Team](#).

## Additional Information

### SAFEGUARDING AGAINST HARASSMENT AND ABUSE

In accordance to World Rowing's [Code of Ethics](#) (World Rowing Statutes, Appendix S11 – Bylaws to Article 58) USRowing is committed to safeguarding and protecting the welfare of all athletes, coaches and staff members. The High Performance Committee, in accordance with the USRowing Medical Committee, shall appoint a Safeguarding Officer for each National Team activity (Trials, Selection Camps, International Regattas).

Anyone who has a concern about a possible incident of harassment or abuse that relates to National Team activities should report it to the Safeguarding Officer. Directly affected individuals as well as third-party individuals who have witnessed a possible incident of harassment or abuse can report the incident. Any person who reports a possible incident of harassment or abuse in good faith shall not be subject to reprisal because of submitting a report; their identity shall be treated confidentially. These protections shall not apply to a person intentionally making false accusations.

Any information pertaining to an alleged incident of harassment and abuse shall be regarded as confidential and shall be shared on a strictly 'needs to know' basis with the Chair of the High Performance Committee. In particular, reports shall be treated confidentially and information (including name, date of birth, address of the concerned person or third party) shall not be disclosed, except, for example, if prior consent is given by that individual or if disclosure is necessary to protect someone from harm.

The Safeguarding Officer will, together with the Chair of the High Performance Committee identify the jurisdiction of the report. If the report is considered to relate to a criminal offence, it shall be referred to the Police and relevant authorities; If the report is considered to be outside USRowing's jurisdiction, it shall be referred to the appropriate person or organization. If the report is considered to be within USRowing's jurisdiction, they will carry out an assessment. For all cases, regardless of jurisdiction, the Safeguarding Officer shall keep the directly affected individual(s) and/or third party informed on next steps.

### USOPC ATHLETE OMBUDSMAN

The Athlete Ombudsman provides cost-free, independent and confidential advice regarding athlete rights, grievance procedures and any other related guidance pertaining to selection procedures and can assist in mediating disputes between athletes and their NGB/HPMO.

## **INTERNATIONAL DISCLAIMER**

These Selection Procedures are based on World Rowing and/or USRowing rules and regulations as presently known and understood. Any change in the Selection Procedures caused by a change in World Rowing and/or USRowing rules and regulations will be incorporated herein and distributed to the affected athletes immediately. The selection criteria are based on the latest information available to USRowing. However, the selections are always subject to unforeseen, intervening circumstances, and realistically have not accounted for every possible contingency.

## **PRIORITY OF WRITTEN PROCEDURES**

The terms and conditions of these written Selection Procedures shall take priority over any verbal explanation, clarification or interpretation of the Selection Procedures, and an athlete or coach relies on a verbal explanation, clarification or interpretation of these Selection Procedures at his or her sole risk. Any request or question that would involve a formal clarification or interpretation of these Selection Procedures, or that would address an issue not otherwise covered in these Selection Procedures, should be submitted to the Chief High Performance Officer at USRowing in writing, and the response to such request by USRowing must be provided in writing and must be published promptly on the USRowing website.

## **ANTI-DOPING AND SAFE SPORT VIOLATIONS**

If an athlete is alleged to have committed an anti-doping rule violation, that athlete shall remain on the Team (or remain eligible to be nominated to the Team) until: a) the athlete is provisionally suspended or declared ineligible after a hearing conducted pursuant to the U.S. Anti-Doping Agency Protocol for Olympic Movement Testing or by World Rowing; b) the athlete voluntarily accepts a provisional suspension or sanction of ineligibility; or c) the athlete voluntarily withdraws from the Team or relinquishes eligibility to be nominated to the Team.

## **SUPPORTING DOCUMENTS**

USRowing will retain all supporting documents, including scouting or evaluation forms, etc., and data from the selection process for six months past the date of the 2026 World Rowing Championships. Records pertaining to a specific selection process under these procedures will be made available for review to an athlete involved in such selection, upon written request to the Chief High Performance Officer.
