

2026 USRowing Learn to Row Sweepstakes

Official Rules

Eligibility

To enter the 2026 USRowing Learn to Row Sweepstakes (“Sweepstakes”) on behalf of your organization, you must be a legal U.S. resident who physically resides in one of the 50 United States or the District of Columbia and be 21 years of age or older at the time of entry.

Officers, directors, employees, committee members, agents, and representatives of USRowing or its affiliates or sponsors involved in the Sweepstakes, their parent companies, affiliates, subsidiaries, service agencies, and independent contractors, as well as their immediate family members and household members, are not eligible to participate.

How to Enter

Entry Method 1 (Online)

2. Host a Learn to Row Day event at your organization on June 6, 2026.

3. Visit <https://form.jotform.com/251004452331037> and complete the Exit Survey between June 7, 2026 and June 30, 2026.
4. Have at least one Learn to Row Day attendee purchase a USRowing Learn to Row membership and affiliate with your organization through the USRowing member portal.

All entries must be received by 11:59 PM ET on June 30, 2026. Limit one (1) entry per organization for each Learn to Row Day attendee who purchases a USRowing Learn to Row membership and affiliates with your organization.

Entry Method 2 (Mail-In Entry)

To enter by mail, print the following information on an 8.5" x 11" sheet of paper:

- The words: "2026 Learn to Row Day Sweepstakes"
- Your first and last name
- Member organization name
- Address, city, state, and zip code
- Telephone number
- Email address
- Confirmation that a USRowing Learn to Row Day event was hosted on June 6, 2026
- Give feedback on how USRowing can support your organization in future Learn to Row events
- USRowing member numbers of attendees who purchased Learn to Row memberships and affiliated with your organization
