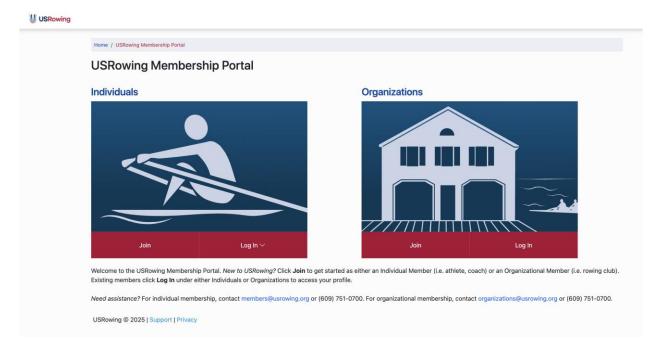

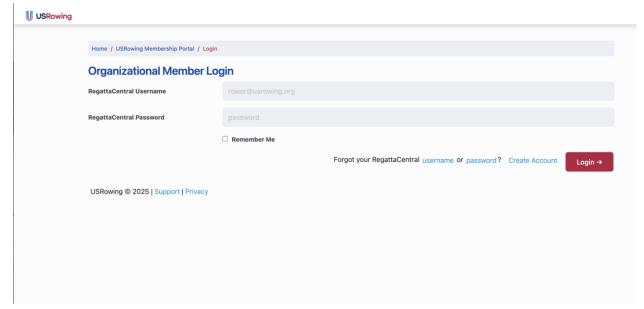

Step 1: Navigate to the USRowing Member Portal <u>HERE</u> and click *Join* under Organizations.

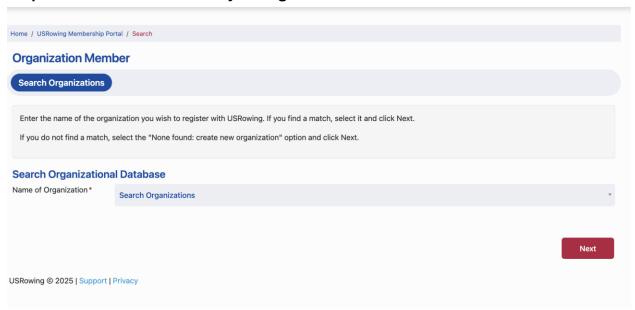


# Step 2: Enter your RegattaCentral username and password. If you do not have a username and password, create on <u>HERE</u>.

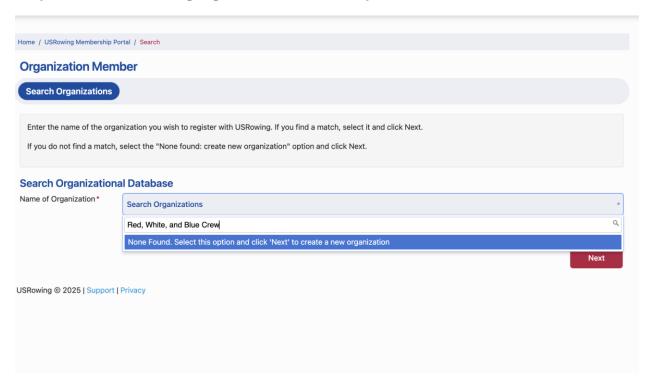




Step 3: Search for the name of your organization in the search bar below.

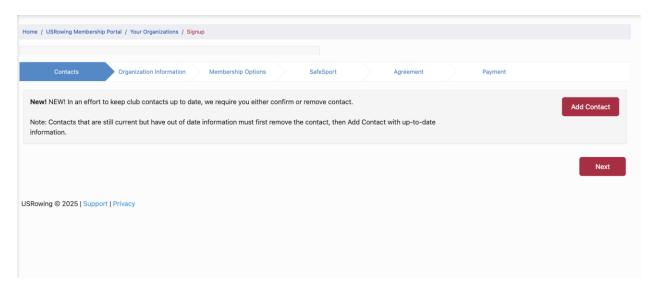


#### Step 4: Click the blue highlighted text bar that says None Found, then click Next.

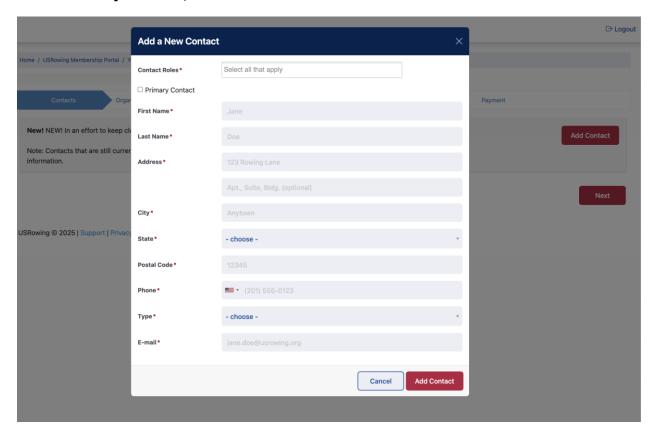




Step 5: Add a primary contact to your organization by clicking Add Contact.

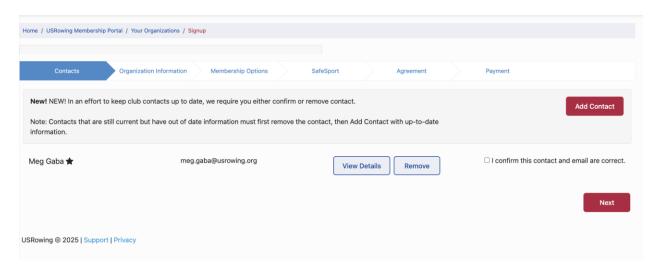


Step 6: Enter all required contact details, click the checkbox designating this person as the Primary Contact, and click *Add Contact*.

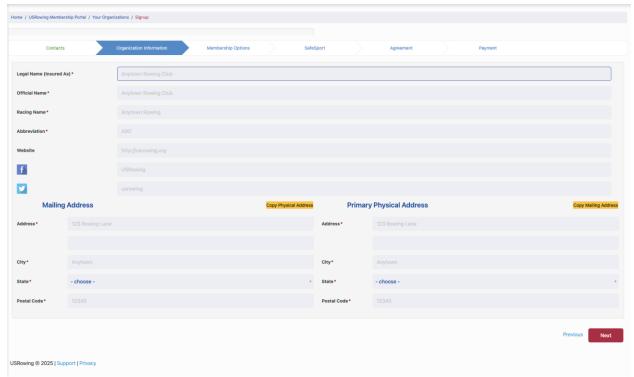




## Step 7: Confirm the contact and email address are correct by click the checkbox, then click *Next*.



#### Step 8: Enter the organization's details, then click Next.



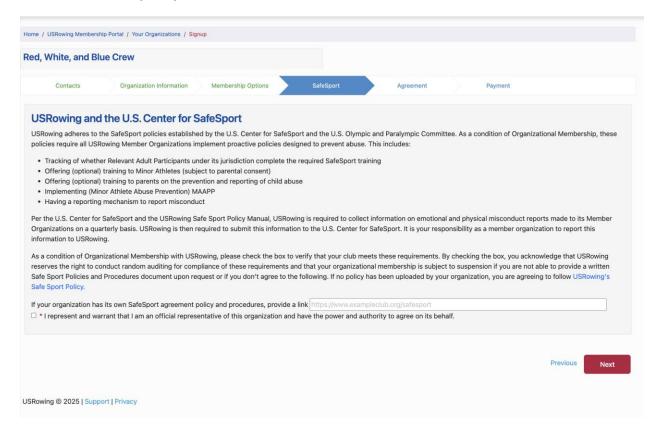

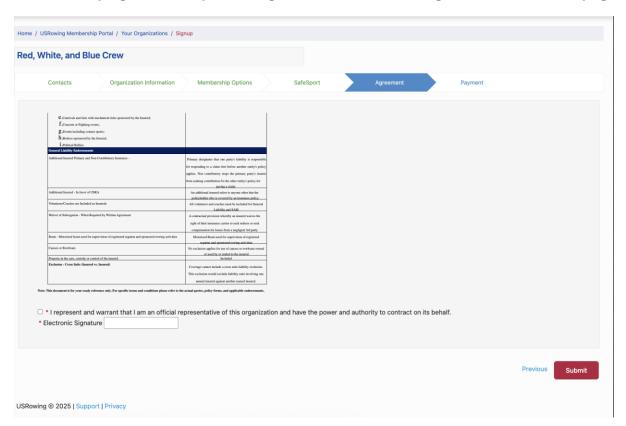


### Step 10: Review and click the checkbox that you agree to USRowing and the U.S. Center for SafeSport policies.
